#### 24-25/101 Chairmans Report

APP/Y3940/W/24/3344456 - PLANNING PUBLIC INQUIRY - PL/2023/03298 - Land at Wheatleys Farm, Ashton Keynes, Swindon

At our meeting on 18 September 2024, we were of the understanding that Wiltshire Council were still intending to defend their refusal of the application to quarry sand and gravel at Wheatleys Farm, at the upcoming appeal on this matter. Almost immediately after that meeting, we learned that Wiltshire Council had decided, at the eleventh hour, not to defend their refusal. We immediately alerted Parishoners to this. A lot of people expressed their concerns forcefully at a Wiltshire Council (Malmesbury Area Board) Meeting which happened to be being held in our own Village Hall on 24 September. Recognising that we, the Village, suddenly had to fight this alone, a public meeting was hastily arranged for the following evening. A plan of action was devised, and a team formed, made up of Parish Councillors and concerned Parishioners. It was very gratifying that so many people volunteered their time to support the cause.

The Appeal Inquiry, to be heard by an independent Inspector, was due to start on 15 October. Because, through no fault of our own, we had very little time to prepare our case, our first objective was to try and get the appeal postponed. However, despite putting forward a strong legal case (drawn up by three solicitors who had volunteered their services), the Inspector

rejected our request. Anticipating this possibility, another part of the team had been working, in parallel, incredibly hard, to enable us to put up the best defence of our case at the Inquiry. We also embarked on a campaign to raise public awareness of our plight, culminating in a visit by a television crew from BBC Points West who filmed and interviewed villagers at an ad hoc protest by our Best Kept Village sign. The resulting programme was broadcast at least three times.

The Inquiry itself, held over a four-day period in Chippenham, was challenging for us. The Appellant had a barrister (a KC) supported by a team of expert witnesses and we also found ourselves effectively being opposed by Wiltshire Council, complete with a barrister. We were further hampered by a very inefficient administration in the Planning Inspectorate, and an Inspector who, at times, appeared to be very hostile towards us. Nevertheless, we fought hard all the way and, in boxing parlance, 'landed a number of good punches'. The issues that we raised centred around the need for a quarry at this particular site (given that it has been acknowledged that the material extracted will be of poor quality), flood risk, noise and dust, transport concerns, ecology issues and, of course, the proximity of the proposed quarry to the houses in Maisey Mews and Heavens Rise. As well as our own team, we were grateful for people with specialist skills who volunteered to speak in our support.

We are grateful to the many parishioners who showed their support by making written submissions and also attending and speaking at the Inquiry. However, because of lack of an agenda until just before the start of the Inquiry, and because of the inflexibility of the Inspector, a number of parishioners felt that they were not able to make their points as clearly as they would have liked.

The Inquiry finished on Friday 18 October 2024 (Actually it was adjourned until 28 October, but this was just a technical adjournment to allow for certain administrative matters to be cleared up.) We still have rightful indignation at the way that we have been treated by Officers at Wiltshire Council, the Planning Inspectorate administration and indeed the whole process. To say that the odds were stacked against us is an understatement. We are now considering what, if anything, we can do in that respect. Along with the injustices, we have identified several legal discrepancies which we are reviewing to see whether there is scope for taking any further action. Our MP, Roz Savage, is also pitching in on our behalf and alongside our late representation, will be writing to the Planning Inspectorate.

I would like to conclude by thanking the 'defence' team for all their work. They put in long hours, both before and during the Inquiry, often working late into the night. Their passion and enthusiasm remained undimmed throughout the whole process.

I would like to thank Parishioners for all their support and also those who contributed to the crowd-funding appeal which helped fund our activities.

Notwithstanding any last-minute efforts to thwart the process, we now await the Inspector's verdict, which may take a few weeks.

Cllrs Berry and Grant are taking up the issues with Wiltshire Council and the perceived failings.

#### 24-25/102 Clerks Report

The external auditors have completed the review of the Annual Governance and Accountability Return for the year ended 31st March 2024. Wiltshire Council Highways have confirmed that this is the responsibility of the Church as landowner.

Email received requesting bridleways be cut back. No specific location given, advised to report to Wiltshire Council and passed on to the Footpaths Working Group.

Email received regarding lack of visibility looking left as you cross the B4696 on the Thames Path towards Lower Mill.

The Parish Steward has carried out cutting back.
