Comments: Objection: Whilst we acknowledge that the owner wishes to improve security at lake 62, AKPC are concerned that the proposed new fence is visually out of keeping with the area. The proposed security fencing, which, it is planned to be immediately adjacent to the carriageway, will appear stark and utilitarian within its largely rural setting. AKPC would wish to have any fencing of this nature set well back into the applicant's land, ideally behind the existing tress and hedges, which would therefore act as a screen. This

condition is particularly pertinent at the south-eastern end of the site, where it borders the C85 (Spine Road West) and the C2 (the road north towards Siddington).

The application form states that the proposals will have an effect on the ecology of the site, yet there is no ecology report provided, so it is difficult to assess this impact. We are concerned that the proposals will involve cutting down hedges and trees, yet there is no drawing or report that sets out the scale and magnitude of these works.

Finally, there has been a long-standing ambition from various stakeholders to provide a cycle path that connects Keynes Country Park to the main cycle track along Spine Road East. (Provision for part of this cycle path, at the southern edge of the adjacent Cotswold Community site, has been built into the agreed planning permission granted for the development of the Cotswold Community site.) With the security fencing proposed so close to the road edge, this would prohibit the realisation of this project in the future.
